## **Role of the Social office**

### **Legal basis :**

The way in which social assistance is organised, and the composition and role of the social office, was reformed by the law of 18 December 2009, and the Grand-Ducal Regulation of 8 November 2010, both of which came into force on 1 January 2011.

### **Social assistance :**

The right to social assistance has been established created in order to allow everyone to a life live their lives within conformity with human dignity. Social assistance is focused on short, medium, or long- term social support to help those people in need and their families, either to acquire or preserve their independence, autonomy and to avoid poverty and social exclusion. If necessary, the support provided may will be accompanied by material assistance in kind or in cash. Any person residing in the Grand Duchy of Luxembourg is entitled to social assistance. It is from provided by the social office.

### **Social office :**

Each Commune with at least 6.000 inhabitants has its own social office, either under its own supervision, or jointly with another social office. Communes with a population of less than 6.000 inhabitants come together with one or more other Communes in order to reach a population of at least 6.000 inhabitants, and to form a joint social office under the supervision of its principal Commune. The social office's administration is carried out by a board of directors composed of at least five members.

To comply with the above legal and regulatory requirement, the Communal Councils of Mondorf-les-Bains and Dalheim decided to set up a joint social office and to officially name it "Mondorf-les-Bains/Dalheim joint social office". The office is located Mondorf-les-Bains, and there are seven members on the board of directors (five representatives from Mondorf-les-Bains, and two from Dalheim).

The Mondorf-les-Bains/Dalheim joint social office is responsible for Altwies, Dalheim, Ellange, Filsdorf, Mondorf-les-Bains, and Welfrange.
